Current news:

UKRI announced final names for [executive roles](#) with Professor Melanie Welham selected as the Executive Chair of BBSRC and Professor Lynn Gladden selected for the role of Executive Chair of the EPSRC. Dr Ian Campbell was also appointed Innovate UK interim Executive Chair.

Defra Consultation [The future for food, farming and the environment](#) closed on the 8 May 2018. More than 44,000 responses have been received on the government's proposals for the future once we leave the EU. A recent WWF poll, undertaken by Populus, found that [91 per cent of the UK public want to see farmers paid to protect nature](#). Responses to the consultation will now be analysed carefully and the Government will publish a response shortly.

New report published in March by the Lords Selected Committee says ['Rural communities are being failed by Government'](#). The committee argues diminished resources given to departments and bodies to protect the UK's natural environment and promote the needs of rural communities had a profound, negative impact on England's biodiversity, environment and the social and economic welfare of rural areas.

In late April, it was announced that [further restrictions on neonicotinoid pesticides](#) have been approved following a vote in the European Commission. The UK voted in favour of the proposals that will see a ban on outdoor use of three neonicotinoids - Clothianidin, Imidacloprid and Thiamethoxam and stated, unless the scientific evidence changes, the government will maintain these increased restrictions post-Brexit. However, the UK reserves the right to consider emergency authorisations. They will only do so where there is a real need for the products and the risk to bees and other pollinators is sufficiently low.

[New agritech partnership has been announced by Cambridge](#) and four other universities (East Anglia, Hertfordshire, Lincoln and Reading) including the John Innes Centre, NIAB and Rothamsted Research. The partnership aims to develop and commercialise agritech research, in order to improve sustainability, increase productivity and contribute to global food security.

The Royal Society of Arts - Food, Farming and Countryside Commission evaluated evidence, from 1,000 proposals in 160 reports, speeches, consultation responses and other documents, all published since 2015. Tom MacMillan (Soil Association) explains more in his [blog](#). They now want your view on practical action that could improve the ways we eat, farm, and regenerate our environment and countryside communities. A [short survey](#) is open until 31st May.

Another initiative from 3keel and the University of Oxford [reviewed 116 studies](#) to better understand [what voluntary sustainability standards deliver on the ground](#) and new evidence suggests that [sustainability standards drive action](#). Examples include the certification scheme from [LEAF Marque](#). Congratulations to Prof Martin Broadley (University of Nottingham) and Dr Louise Ander (British Geological Survey) for winning the [International Impact Awards at the BBSRC Innovator of the Year](#) celebrations. The prize relates to the GeoNutrition project that takes a geographical approach to nutrition linking large-scale soil, agricultural and landscape datasets with factors affecting the supply of micronutrients to crops and food systems. Prof Rosie Hails (CEH and member of SIRN Advisory Board) and Rob Fish (University of Kent) become lead editors of the new journal People and Nature from The British Ecological Society (BES), in partnership with its publisher John Wiley & Sons. [People and Nature](#) is an open access journal dedicated to publishing high-quality, peer-reviewed work from research areas exploring relationships between humans and nature.

Sandpit for early-career researchers at lecturer level and equivalent in any research area covered by BBSRC, NERC and ESRC - [Transforming the food system for health, sustainability and resilience across production and demand](#)

4th-6th July and 19th-20th July 2018 – This activity is part of Global Food Security - Resilience of the UK food system in a global context third call. Expressions of interest are called to address the following question: How can we transform our food system so it is based on healthy and sustainable diets and how would this impact on sustainability and resilient food production and supply? The sandpit will develop outline proposals, a number of which will be invited back to be developed in full proposals. Successful proposals will be jointly funded by BBSRC, ESRC, NERC and the Scottish Government and up to £1.8 million (80% FEC) is available. Application deadline: 23rd May 2018, 16:00

UKRI New Fellowship scheme - [Future Leaders Fellowships](#) scheme providing up to seven years of funding, for at least 550 early-career researchers and innovators, the scheme will tackle difficult and novel challenges.

There will be six calls for the FLFS, with two calls taking place each year over the next 3 years. Applications can be submitted in any area of research or innovation covered by Research Councils and Innovate UK.

Deadline for first call: 03rd July 2018, with a mandatory Expression of Interest required by 7th June.

NERC Innovation Placements - NERC invites applications from existing researchers (at post-doctoral level or above) for [Innovation Placements](#) - 3 to 12 month placements based in non-academic organisations. Projects must fall within the [NERC remit](#) and must identify clear examples of where environmental research, data and skills can be used to make a difference.

Application deadline: 4th July 2018, 16:00
